Administrative Reports

Heather Cox said the week the 7th graders spent at Wolf Ridge went well and said the students enjoyed the experience. She also mentioned that two agencies have come forward to give support with a mentoring program.

Mr. Anderson moved to hire Steve Flach as assistant middle school/high school wrestling coach for the 2017-2018 school year, seconded by Mrs. Pesko. Mr. Naglosky recused himself from voting because he felt he is too close to the situation. The motion carried.

Mrs. Nielsen moved to approve that the annual board retreat be held on Friday, January 26, 2017 at 8:00 am at WITC Shell Lake, seconded by Mr. Naglosky. The motion carried.

Committee and President's reports were reviewed.
