

**School District of Shell Lake  
Regular Board Meeting  
April 18, 2016**

Board members were given a tour of the Shell Lake Arts Center prior to the School Board meeting.

President Stu Olson called the meeting to order at 6:00 p.m.

The oath of office was administered to recently re-elected members, Stu Olson and Scott Smith.

During public comments, Lanie Hutton and Cecilia Harrington commented about cheerleading.

Bob Forsythe spoke about the award given to the Shell Lake Middle School by the Wisconsin Technology Education Association for being the Program of the Year and recognized as an outstanding middle school technology program.

**Administrative reports**

Mr. Anderson moved to approve the CESA #11 Shared Services Contract as presented for the 2016-2017 school year, seconded by Mr. Naglosky. The motion carried.

Mrs. Pesko moved to hire Anna Walther as assistant high school volleyball coach for the 2016-17 season, seconded by Mrs. Nielsen. The motion carried.

Mrs. Nielsen moved to approve the issuance of 2016-17 contracts for certified staff, seconded by Mrs. Pesko. The motion carried.

Board members discussed chapter 5 of the Key Work of School Boards.

Committee and liaison reports were reviewed.

Mr. Anderson moved to adjourn the meeting, seconded by Mr. Naglosky. The motion carried. The meeting was adjourned at 8:25 P.M.
